6. Increase in cost of raw materials: Basic raw materials such as tea powder, jaggery, milk, and tea masala are continually increasing, which is further increasing the rate of tea cups.

7. Quality and taste issues: maintaining good quality and taste is another issue in the jaggery tea business. Small changes in the ingredients may change jaggery tea quality and taste.

1.4 Suggestions

1. To start a franchisee jaggery tea business, franchisers have to charge less money in the initial stage to the business starters, which reduce their burden.

2. To avoid competition in the jaggery tea business, owners must search the area to start shops where more population is available and fewer shops are established.

3. Shops need to maintain good quality and taste in the jaggery tea, which helps attract more customers to the shops.

4. Except for health and hygiene, the remaining cost must be reduced to decrease the cost of tea.

5. Some value-added materials, such as ready-made bread, bakery items, biscuits, and jaggery cakes, should be sold along with the jaggery tea business, which helps to earn more profit.

6. Franchisers have to offer a credit facility to new Jaggery Tea business starters, which helps reduce the financial burden.
